1. Orphans of both parents, those from orphanages or foster care, children of martyrs of the December 1989 Revolution, children of POLITEHNICA Bucharest employees and retirees, as well as employees, will be exempt from the fee.
2. Exceptions are the *study programs in engineering sciences, Performing Arts (Acting), Sacred Art, General Medical Assistance, Law, Kinesiotherapy and Special Motricity, and Music*.
3. For POLITEHNICA Bucharest employees, the fee will be covered by the university, from its own revenues, only for one study program.

4. It is paid by doctoral/postdoctoral students who are Romanian citizens, enrolled in fee-based programs, and by doctoral students enrolled in non-fee-based programs who have exceeded the duration of 5 years of the doctoral stage (4 years + 1 year extension).
  5. The fee can be paid in 2 equal installments, in October and March of the current academic year.
  6. Exceptions are employees (active, retired, or deceased) who have or had a work card at POLITEHNICA Bucharest.
  7. Individuals who at the date of the public defense have a work contract with POLITEHNICA Bucharest are exempt from the fee.
  8. For POLITEHNICA Bucharest teaching staff who supervise at least 2 doctoral students at the first doctoral admission competition organized after habilitation, the fee is 150 RON. If this is not confirmed, the teaching staff will pay the fee of 3000 RON.

**REMARKS:**

1. The tuition fees for undergraduate, master's, and doctoral studies in fee-based programs are valid for the cohorts starting these respective studies this year.
2. The fees for postgraduate and professional conversion programs are approved individually for each program when endorsed by the University Senate.
3. The tuition fees (positions 11-21 and 34-35) will be indexed annually according to the inflation rate over the last 12 months (rounded to the nearest tens).
4. The discipline retake fee (item 24) will be 350 lei in the 2026-2027 academic year and 400 lei in the 2027-2028 academic year.

The expedited issuance is conditioned by the receipt of diploma forms from the institution authorized to print them. The fee applies within 12 months of passing the final exam / 2 months after the issuance of the order granting the doctoral title. The deadline for issuance is a maximum of 5 working days from the registration of the request	250
